Turkey in the World Economy: Challenges and Perspectives

Overview

This year's Bachelor seminar in International Economics in the Bachelor program focuses on current economic developments in Turkey and its role in the global economy. Central aspects of the Turkish economy in an international context will be addressed, including Turkey's trade relations with the European Union, the role of foreign direct investment and international migration flows. Participants will work on these topics independently by preparing a seminar paper and an accompanying presentation. Successful completion of the seminar confers 6 ECTS credits, which can be counted according to the credit options listed below.

Organisation

Target group and credits The seminar is offered to Bachelor students of Business Administration and Economics. Students from other degree programmes cannot earn credit. A prerequisite for participation is proof of 72 ECTS credits from the core studies. Depending on the topic's content, knowledge from the bachelor courses Reale Außenwirtschaft and/or Monetäre Außenwirtschaft is also required. Basic knowledge of the Turkish economy and its international economic relations is advantageous. Economics students may count the seminar toward the mandatory seminar module or alternatively the elective module. Business Administration students may count it toward the supplementary seminar module.

Seminar paper Requirements include the mandatory attendance at a preparatory meeting at the beginning of the lecture period (probably in the second week), submission of a written paper of about 15 pages of body text¹ by the deadline and delivery of a presentation supported by slides. To obtain credit, a grade of at least 4.0 (sufficient) must be achieved in both the written paper and the presentation. The preparatory meeting provides an introduction to writing academic texts and giving presentations; it also offers an opportunity for discussion and clarification of open questions. After that, questions can only be addressed in a one-hour outline meeting with the supervisor.

Block seminar Presentations will take place as a block seminar around mid-January. The exact date will be arranged with the participants. A one-page thesis handout, to be submitted at least one week before the presentation and briefly explained to the supervisor, is part of the requirements. It helps the other participants follow the presentation and ensures a clear structure.

Registration Registrations must be submitted in writing to Mehmet Burak Akren (R12 R07 A11). Registration is open immediately until and including 03 October 2025 (deadline). Prior registration for office hours by e-mail is mandatory: mehmet.akren@vwl.uni-due.de. Bring the completed registration form attached to this document. Registering simultaneously for seminars at other chairs may result in exclusion from both.

After the deadline you have one week to withdraw from the seminar without consequences. Please do so promptly so that other students may switch topics without losing further time.

Topic allocation Please indicate a first and second preference when registering. Each topic can be assigned to up to two students. Ensuring coverage of all topic areas has priority. Allocation takes place after the registration deadline. Early familiarisation with the provisional topic is welcome but does not entitle you to it.

Coordination / materials All information will be communicated via the Moodle course room, including introductory literature, scheduling and all other arrangements.

Literature The sources listed are instroductory reading. Independent study of additional literature is essential and should rely exclusively on scholarly sources such as peer-reviewed journals and reputable working-paper series. To evaluate your sources, you can use, for example, the journal rankings of Handelsblatt, Scimago, VHB and the Institute for the World Economy. Some literature is subject to license and can therefore only be downloaded via the university network.

Schedule Within three weeks after the introductory session all participants must consult their supervisor with

- An outline that already shows a logical thread and follows a consistent style,
- A preliminary bibliography that contains the key sources and follows the formal requirements and
- A drafted introduction (about one page) giving an impression of the planned content and structure.

All three documents must be submitted to the supervisor by e-mail before the outline meeting. Writing the seminar paper full-time should take about 3–4 weeks, plan accordingly.

Submission Two printed copies of the seminar paper, stapled with a prong fastener, must be submitted no later than 19 December 2025, 12:00 pm to the chair's secretary's office (R12 R07 A05). A digital version must be e-mailed to the supervisor by the same deadline.

Formalities Guidelines on formal requirements are available in Moodle. Serious violations may lead to grade deductions or even failure.
